Superintendent Kornegay along with Mr. Scott Ward presented their stance that a charter renewal for the 2022-2023 would not be recommended for Alee Academy at this time with the current financial, enrollment, and student performance concerns. Superintendent Kornegay presented potential next steps for not only taking care of the students currently enrolled at Alee Academy, but for the facility as well going forward. It was decided that Alee Academy's Charter Board will hold an Emergency Executive Session on February 3, 2021 @ 5:30 pm to discuss the future of Alee Academy going forward in depth. Lake County School board member Stefanie Luke was also in attendance as well.***
