Coach Aaron Feis School Guardian Program – LCSB voted on 6/11/2018 to approve the guardian program in order to be compliant with the new safety/security state statutes at the start of the 2018-2019 school year. The Superintendent's recommendation was that administrators only be given the training to be the designated guardian on the elementary school campuses and as monetary resources and deputies become available, she will place deputies on those campuses to eliminate the need for the guardians to fill that role. She left participation in the guardian program up to charter boards for the charter schools. We will need a decision on participation for Alee Academy. See attached job description for a School Safety Guardian.

Motion was made by B. Grassel to approve Alee Academy's participation the Coach Aaron Feis School Guardian Program with a new hire that has a background in law enforcement and seconded by Jennings Neeld. The motion passed unanimously.

New Business

Mental Health Plan – All school have been allocated money to develop a mental health plan. As we are a small school with limited resources, I have informed Dr. Kristine Landry with LCS that we will defer our dollars to LCS and participate in the plan that they are developing.

All in attendance were updated on the status of the Mental Health Plan required by the state and were in agreement given the nature of our school and the current resources that pooling our dollars with LCS was the best option for us to be in compliance.
